Flock Safety network audit logs and organization audit logs for the month of February 2026.

This letter follows up on three California Public Records Act requests, in which I requested the Flock Safety network audit logs and organization audit logs for November 2025 through March 2026.

- 26-5814, submitted February 26, 2026
- 26-11951, submitted April 25, 2026
- 26-11952, submitted April 25, 2026

In response to all three requests, the Department produced a single .xlsx file which is missing substantial information. The file appears to be a portion of the network audit logs, with several columns removed, including officer name, search reason, license plate, and many others. The response did not identify what was removed, why it was removed, or what legal basis supports the removal. Furthermore, the file does not include the requested Organization Audit Logs.

I am writing to ask the Department to correct this issue, and also provide the records in their original electronic CSV format, as required by Government Code § 7922.570. These records can be downloaded from the Flock admin dashboard, without any extra data compilation, extraction, or programming.

Government Code § 7922.000 requires an agency to justify any withholding or redaction by demonstrating that the specific material is exempt under an express provision of the Public Records Act, or that the public interest served by withholding it clearly outweighs the public interest in disclosure. A general or unexplained removal of information does not satisfy this standard. Accordingly, I am requesting a written statement identifying, for each category or field of information that was removed from the audit logs, the specific statutory exemption(s) the Department is relying on to withhold it. Please provide the native CSV export of the requested audit logs, along with the written explanation of any withheld content described above, within ten (10) business days of this letter. If the Department is unable to produce the records in the requested format or does not provide a basis for the redactions, I may seek judicial review by petition for writ of mandate under Government Code § 7923.000. I would prefer to resolve this informally and appreciate the Department's cooperation. Please feel free to contact me with any questions.
